ORIGINAL AGREEMENT: The original agreement (authorized by Board Report No. 00-1220-PR3) is for a term commencing January 4, 2001 and ending June 30, 2002, with the Board having three (3) options to renew the agreement for successive periods of twelve (12) months each. The original agreement was awarded pursuant to a duly advertised Request for Proposals.

OPTION PERIOD: The term of this agreement is being extended for one (1) year commencing July 1, 2003 and ending June 30, 2004.

OPTION PERIODS REMAINING: There is one (1) option to renew for one (1) year period remaining.
