PROGRAM: An educational 5-day tour of Washington DC. from May 19-May 23, 2003.

EDUCATIONAL VALUE/OUTCOMES:

The purpose of this field experience is to:

- Provide pupils first hand experience about the working of the three branches of government in a democracy.
- Develop pupil understanding and appreciation of the responsibilities and rights of citizenship in a democracy.
- Further pupils' awareness of themselves and the possibilities of their own influence and contribution to society.
- Motivate pupils to further their education and develop their talents to better serve, themselves, their families, community, and Country.
- Give pupils a "real life" opportunity to develop skills individually and as a group, to set goals, develop action plans and strategies, make decisions and choices to accomplish goals.
- Enhance pupils' study of American History, and the U.S. Constitution.
- No child will participate in water activities.

TRAVEL ARRANGEMENTS/ TRIP INFORMATION: Arrangements for this program are being made by Educational Tours, Inc. - Vendor # 15208. A detailed itinerary and insurance information are attached.

COST: The per pupil cost is \$598 x 42 which includes transportation by bus, meals, hotel accommodations, health and accident insurance, admission fees, and chaperones. The costs will be paid by an allocation of \$12,500 from NCLB FUNDS, and fund-raising activities so that no pupil would be excluded for financial reasons.
