ADJUST ATTENDANCE AREA FOR JOHN HAY COMMUNITY ACADEMY, RONALD MCNAIR ELEMENTARY SCHOOL AND FREDRICK A. DOUGLASS JR. HIGH ACADEMY AND CHANGE THE GRADE STRUCTURE OF MCNAIR ELEMENTARY SCHOOL AND DOUGLASS JR. HIGH ACADEMY

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Effective immediately, adjust attendance boundaries for John Hay Community Academy, located at 1018 North Laramie Avenue, Ronald McNair Elementary School, located at 4820 West Walton Street, and Fredrick A. Douglass Jr. High Academy, located at 543 North Waller Avenue.

DESCRIPTION:

These changes are due to the completion of the new Ronald McNair Elementary School located at 4820 West Walton Street and to more evenly distribute the utilization rates of both Hay and the new McNair. This action assigns a portion of McNair's western attendance area to Hay school. Students residing between Laramie and Leamington and currently enrolled at McNair may choose to remain at their current school or transfer to Hay. Students currently enrolled at Hay but residing within the McNair attendance area may remain at Hay if they so choose.

McNair currently serves grades kindergarten through fifth grade, with grades six and seven attending Douglass Jr. High Academy, and eighth grade attending Michele Clark.

Pursuant to Board Report No. 02-0626-EX02 Douglass Jr. High Academy will extend to eighth grade for the McNair attendance area effective July 1, 2004.

Effective September 1, 2003, change the grade structure at McNair from kindergarten through fifth grade, to grades kindergarten through sixth. Seventh grade students in the McNair attendance area will continue to attend Douglass Jr. High Academy, eighth grade students in the McNair attendance area will continue to attend Michele Clark.

Effective September 1, 2004, change the grade structure at McNair from kindergarten through sixth grade, to grades kindergarten through seventh. At this time, the eighth graders will remain at Douglass Jr. High Academy.

Effective September 1, 2005, change the grade structure at McNair from kindergarten through seventh grade, to grades kindergarten through eighth. At this time, Douglass Jr. High Academy will no longer act as a middle school for the McNair attendance area.
