PROGRAM: This program will consist of 10 days in Switzerland.

EDUCATIONAL VALUE/OUTCOMES: The purpose of this trip is to immerse the students in the Swiss culture and expose them to museums and other historical landmarks of Lucerne.

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Walter Payton College Prep.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

AFFIRMATIVE ACTION: Not applicable.

LSC REVIEW: This tour was approved by Walter Payton College Prep Local School Council on December 17, 2003.

FINANCIAL: No cost to the Board.

GENERAL CONDITIONS:
