- Provide students first-hand experience with the workings of the three branches of government.
- Serve as a culminating activity to Illinois Learning Standards, Goals and Benchmarks 14-B-3, 14-D-3, 14-E-3, 14-F-3a, 14-F-3b, 16-B-3a, 16-B-3b, 16-B-3d
- Enhance student's study of American History and the United States Constitution.
- Further pupil's awareness of themselves and their potential influence and contribution to society.

COST: The per pupil cost is \$445 which includes transportation, meals, hotel, costs, health and accident insurance, trip admission fees, and chaperones. PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Northwest Middle School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.
