PROGRAM: In conjunction with its CHOICE Program (a school wide initiative supported by the Ogden Local School Council) William B. Ogden will send students to Puerto Vallarta and Pitillal, Mexico. The dates of travel are October 29, 2005 thru November 6, 2005.

EDUCATIONAL VALUE/OUTCOMES: Students in the CHOICE Program at Ogden study a curriculum that blends culture, art, architecture, cuisine and the study of foreign language into a comprehensive unit of study. Ogden's CHOICE Program was developed by teachers to extend the students' focus from their immediate surroundings (Chicago's Gold Coast), to that of a world view. CHOICE has evolved into an academic "course" in which students will learn history, language, art, and customs directly relating to Mexican culture. The culminating field experience is the study trip abroad. The students and their teachers will follow a predetermined itinerary of historical sites and cultural interests related to the specific curriculum.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being made by William B. Ogden School.

COST: The cost per person is \$750.00 which includes air transportation, meals, and lodging. The costs will be paid by the students. Chaperones expenses will be covered by rental income per approval by the Ogden School Council.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03-0527-P001 ("Policy on Student Travel"), including the proper ratio of students to adults.

Traveling with the students will be Anthony Vandarakis (Teacher), Jose Guerrero (Teacher), Sarah Manuel (Teacher), and Rachel Mota (Teacher).

PARENTAL CONSENT: Written parental consent and release forms for each student will be on file at William B. Ogden Elementary School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

AFFIRMATIVE ACTION: Not applicable.

LSC REVIEW: The Local School Council approved the CHOICE Trip on April 4, 2005.

FINANCIAL: No cost to the Board.

GENERAL CONDITIONS:

Inspector General – Each party to any agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – Any agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one-year period following expiration or other termination of their terms of office.

Contingent Liability – Any agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
