## REQUEST FOR DISMISSAL OF ROBIN L. JOHNSON, CUSTODIAL WORKER, JENSEN SCHOLASTIC ACADEMY

## TO THE CHICAGO BOARD OF EDUCATION

## THE CHIEF EXECUTIVE OFFICER RECOMMENDS THE FOLLOWING:

That this Request for Dismissal and charges and specifications preferred by the Chief Executive Officer against Robin L. Johnson be approved; that notice of his dismissal and a copy of this Board Report and accompanying charges and specifications be served upon him within ten (10) days of adoption of the Board Report.

## **DESCRIPTION:**

Pursuant to Section 6 of Board Policy 04-0728-PO1and the Rules of the Board of Education of the City of Chicago, the Chief Executive Officer charged Robin L. Johnson, a custodial worker assigned to the Jensen Scholastic Academy, 3030 West Harrison Street, Chicago, Illinois 60612, with irregular or poor attendance, tardiness, or pattern of repeated absence or tardiness at a specific time or on specific days of the week or month, or in relation to holidays; insubordination such as the failure to carry out a rule, order, or directive related to the performance of one's duty; violating School rules, or Board rules, policies or procedures that result in acts of inappropriate behaviors in the school, or on the school grounds or assigned work location, or while attending school functions; repeated or flagrant acts of Group 2 misconduct; having recurrently poor attendance, tardiness, or a repeated pattern of absences or tardiness at a specific time or on specific days of the week or month, or in relation to holidays; violating School rules, Board rules, policies or procedures that results in behaviors that disrupt the orderly educational process in the classroom, in the school, and may occur on or off the school grounds or assigned work location; repeated or flagrant acts of Group 3 misconduct; excessively poor attendance or tardiness; and violating School rules, Board rules, policies or procedures that result in behaviors that seriously disrupt the orderly educational process in the classroom, in the school, and may occur on or off the school grounds or assigned work location.

The Chief Executive Officer hereby requests the dismissal of Robin L. Johnson from the employ of the Chicago Board of Education. Robin L. Johnson has been afforded a discharge hearing and the Chief Executive Officer has suspended Robin L. Johnson without pay.

He will be dismissed from employment immediately upon service of the notice of dismissal together with a copy of this Board Report and the charges and specifications.
