## APPROVE THE PARTICIPATION OF WESTINGHOUSE CAREER ACADEMY IN AN EDUCATIONAL TOUR TO VERACRUZ, MEXICO

**PROGRAM:** In conjunction with the study of the Spanish language, history, and culture at Westinghouse Career Academy, the school will send twelve (12) students plus two (2) chaperones to selected cities in Mexico. The students will have classroom instruction in Spanish focusing on verbal skills, tour museums, businesses, and they will tour a number of Afro-descendent communities in the state of Veracruz.

**EDUCATIONAL VALUE/OUTCOMES:** There is no greater value than traveling and experiencing another culture. The students will improve their language skills because they will be surrounded by Mexicans and will have the opportunity to use the language everyday either in class or during planned excursions. Students will learn the culture, history, customs and traditions of Mexican, Afro-Mexican, and Indigenous peoples of the Veracruz region and be immersed in the Spanish language (Goal #4, 28, and 29). Students will have the opportunity to expand their knowledge of the Spanish language and the customs and history of Mexico. All students are currently enrolled in a second year of Spanish. Our Westinghouse Career Academy students will come away from this experience more confident and with an expanded understanding of themselves and the world around them.

**TRAVEL ARRANGEMENTS/TRIP INFORMATION:** Arrangements for this program are being made by Travel Evolution, 6206 W. 128<sup>th</sup> Place, Palos Heights, Illinois 60463.

**COST:** The cost per person is \$825.00 which includes [transportation, meals, hotel, costs, health and accident insurance, trip cancellation insurance, etc. The costs will be paid by Westinghouse Career Academy parents.

**CHAPERONES:** Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel"), including proper ratio of students to adults.

Traveling with the students will be Ms. Leslie Gordon (Spanish Instructor), and Mr. Charles Anderson (Spanish Counselor).

**PARENTAL CONSENT:** Written parental consent and release forms for each student are on file at [name of Westinghouse Career Academy.

**AUTHORIZATION:** Authorize the President and Secretary to execute any travel agreements necessary for this program.
