PROGRAM: The Sankofa Youth Enrichment Program aims at encouraging the student to feel that he/she is part of a long continuum that is African-American history-therefore each person must take responsibility for his/her actions and accept that he/her choices will impact this continuum.

EDUCATIONAL VALUE/OUTCOMES: The Sankofa Youth Enrichment Program is uniquely designed opportunity for youth between the ages of 13 and 18 to fully engage their rich cultural legacy through a host of empowering educational experiences. Students are challenged to explore African history and culture by attending a host of workshops, field trips as well as by completing required readings essays and a culminating trip to Accra, Ghana.

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at the Al Raby High School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

AFFIRMATIVE ACTION: Not applicable.

LSC REVIEW: Local School Council approval is not applicable to this report.

FINANCIAL: No cost to the Board.

GENERAL CONDITIONS:
