Approve the participation of twelve (12) Northside College Preparatory High School students in an educational tour to China from March 31, 2007-April 7, 2007.

PROGRAM: The trip will be a culminating event for the colloquium class "China...It's Almost as Good as Being There" and the Academic Decathlon team. The class has been learning about China's history and culture and how that plays into its significance in the modern world. The Academic Decathlon team has been studying about China for the past year. The students will visit the Forbidden City, Tiananmen Square, the Summer Palace, the Great Wall and Beijing 57, a local middle-high school.

EDUCATIONAL VALUE/OUTCOMES: The purpose of the trip is to establish connections between what the students learn in the classroom and the real world. For example, the students have looked at the differences between American and Chinese culture in a school context. While in Beijing, the students will visit Beijing 57, Northside's sister school. The students will learn about school culture in Beijing, reflect on their experience, and compare/contrast their own academic lives with what they came across at the Chinese school. Prior to the trip, the students will communicate with peers from our sister school, Beijing 57. The students will then visit the school and spend a day shadowing their peers, observing classes and going through the notions of a typical Chinese student.
