APPROVE EXERCISING THE OPTION TO RENEW THE AGREEMENTS
WITH VARIOUS PRIVATE SPECIALIZED SCHOOL PROVIDERS, AUTHORIZING AGREEMENTS
WITH OTHER PRIVATE SPECIALIZED SCHOOL PROVIDERS, AND AUTHORIZING
PAYMENTS TO PRIVATE SPECIALIZED SCHOOL PROVIDERS

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Authorize exercising the option to renew agreements with various private specialized school providers ("Providers") listed on Exhibit "A" that have current agreements with the Board; authorize exercising new agreements with those listed Providers that do not have current agreements with the Board; and authorize payments to all listed Providers for covered program services at a cost not to exceed the aggregate amount of \$77,250,000.00 \$65,375,000.00 over a two-year period. Written agreements are being negotiated. Student placements in private specialized schools are made either by the Board directly, by the Department of Children and Family Services (DCFS), by the Department of Mental Health (DMH), or pursuant to court order. The Illinois State Board of Education (ISBE) requires private specialized schools and local school districts to execute Nonpublic Facility Placement Contracts for each student being placed in a private specialized school. Whenever possible, the Board has each private specialized school sign a more detailed Private Specialized School Agreement, but executing these separate agreements is not required by law or by the Board. Information pertinent to this option is stated below.

This amended Board Report is necessary to add one new Provider, remove one Provider, and designate the Providers who will be sent new agreements.

This amended Board Report is necessary to add one additional school to the list of providers affiliated with this program; to revise the financial section and to correct the name of vendor #78.

This third amended Board Report is necessary to add one New Provider to the list of Providers affiliated with this program, remove three Providers, and update legal name of vendor #28.

This fourth amended Board Report is necessary to add three New Providers to the list of Providers affiliated with this program, and to remove one Provider from the list.

This fifth amended Board Report is necessary to do the following: (i) clarify the term for new Private Specialized School Agreements, (ii) remove five Providers affiliated with this program from the list, (iii) update the name of a Provider's school, and (iv) adjust the appropriation for FY08.

ORIGINAL AGREEMENTS AND AUTHORIZATIONS: The original agreements and authorizations authorized by Board Report 04-0728-ED7), in the aggregate amount of \$68,000,000.00 are for a term commencing August 1, 2004 and ending July 31, 2006, with the Board having one (1) option to renew for periods of 2-years each. The authorizing Board Report was amended from time to time as new Providers were added and as some Providers

were deleted. For each added Provider, the agreement term commenced on the date the first CPS student was sent to such Provider's school and the term ended July 31, 2006.

OPTION PERIOD: The term of each new Private Specialized School Agreement is for a period commencing August 1, 2006 or on the date that the Provider's school begins serving CPS students, whichever date occurs later, and ending July 31, 2008. The term of each agreement being extended (Renewal Term) commences August 1, 2006 and ends July 31, 2008. There are no remaining options to renew.

SCOPE OF SERVICES: Each Provider will operate educationally and age appropriate programs, administer appropriate tests, develop and use customized Individualized Education Plans (IEP) for each student, provide student progress reports, and will comply with the service requirements specified in their Agreement.

COMPENSATION: Each Provider shall be paid the rate identified by the Illinois Purchased Care Review Board for each of Provider's schools, not to exceed, in the aggregate, the sum of \$77,250,000.00 \$65,375,000.00 over a two-year period. It is anticipated that costs during the first year will not exceed \$42,125,000.00. It is anticipated that costs during the second year will not exceed \$23,250,000.00. Each agreement will contain a non appropriation clause and will provide that signing the agreement does not obligate the Board to place any students in a Provider's private specialized school(s).

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written contract documents. Authorize the President and Secretary to execute the contract documents. Authorize the Chief Specialized Services Officer to (i) execute all ancillary documents required to administer or effectuate these student placements, the contract documents and any new Private Specialized School Agreements, including but not limited to the Nonpublic Facility Placement contracts required by ISBE; (ii) place students in Private Specialized Schools not included on the attached list on an emergency basis when such placements are warranted by the students' Individual Education Plans, or when such placements are required by court order, by DCFS, or by DMH; and (iii) approve travel reimbursement for parents, guardians, and students making visits as a related service specified in the students' Individual Education Programs (IEP).

AFFIRMATIVE ACTION: Pursuant to section 3.7 of the Revised Remedial Plan for Minority and Women Business Enterprise Contract Participation (M/WBE Plan), this matter is exempt from review because this matter is for tuition payments.

Conflicts- The agreement shall not be legally binding on the Board if entered into in violation of the provisions of ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board member during the one-year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
