THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Establish attendance area for the Austin Community Campus High School. Establish an overlay boundary for the Austin Campus High Schools which include the Austin Business and Entrepreneurship Academy HS, the Austin Polytechnical Academy High School, and the Virtual Opportunities Inside a School Environment (VOISE) Academy High School, located at 231 North Pine Avenue. Establish an attendance area boundary for Frederick Douglass Academy High School located at 543 North Waller Avenue. Adjust attendance areas for Austin Community Academy High School, located at 231 North Pine Avenue, Rezin Orr Community Academy High School located at 730 North Pulaski Road, Roberto Clemente Community Academy High School located at 1147 North Western Avenue, William Harvey Wells Community Academy High School located at 936 North Ashland Avenue, John Marshall Metropolitan High School located at 3250 West Adams Street, Manley Career Academy High School located at 2935 West Polk Street, George W Collins High School located at 1313 South Sacramento Drive.

Public Hearings were held on March 24, 2006 and May 12, 2006 at the Board Offices located at 125 S. Clark discussing the proposed boundary changes. A Public Hearing was held on February 28, 2008 at the Board Offices located at 125 S. Clark discussing the establishment of boundaries and related boundary changes. Furthermore, a public forum was held on March 13, 2008 at the Frederick Douglass Academy High School located at 543 North Waller Avenue to receive comments on the proposal.

DESCRIPTION:

These changes are necessary for the opening of the Austin Community Campus High School and establishment of the Austin Campus overlay boundary and the establishment of the Douglass attendance area boundary to more evenly distribute utilization rates between Frederick Douglass, Rezin Orr, Roberto Clemente, William Harvey Wells, John Marshall, Manley, and George W. Collins High School. All of these schools have adjacent attendance boundaries. The Austin Campus schools referred above will have the same overlay boundary. An overlay boundary provides students who reside within a specified proximity to a school with a preference in any lottery for school enrollment over students who reside outside the overlay boundary. Students residing within the Austin Campus overlay boundary will be given priority for enrollment at the campus schools over those students who reside outside of the overlay boundary. No student will be required to attend Austin Campus Schools. The new overlay boundary may be used for the enrollment and/or lottery procedure beginning with the 2008-2009 school year for the schools referenced above.

The Modified Desegregation Consent Decree entered on March 1, 2004 by the U.S. District Court for the Northern District of Illinois in U.S. v. Chicago Board of Education, 80 C 5124 states; "CPS shall alleviate any racially and ethnically disproportionate overcrowding of school sites, to the extent practicable."
