Approve the pre-qualification status and entering into master agreements with nineteen (19) fifteen (15) Consultants to provide various professional audit and management services to the Board of Education at an aggregate cost not to exceed \$3,000,000.00. Consultants were selected pursuant to a duly advertised Request for Qualifications (Specification No. 06-250059). A written agreement for each Consultant's services is currently being negotiated. No services shall be provided and no payment shall be made to any Consultant prior to the execution of such Consultant's written agreement. The authority granted herein shall automatically rescind as to each Consultant in the event a written agreement is not executed by such Consultant within 90 days of the date of this Board Report. Information pertinent to these agreements is stated below.

This amendment is necessary to remove AON Risk Services, Deloitte & Touche, LLP, KPMG, LLP and RSM McGladrey, Inc. from the list of pre-qualified Consultants. AON Risk Services, Deloitte & Touche, LLP, KPMG, LLP and RSM McGladrey, Inc. declined to execute the agreement.

This amendment is also necessary to update the contact information for Control Solutions International and to update the vendor number for Omotosho & Associates.

TERM: The term of this pre-qualification period and each agreement shall commence on April 1, 2007 and shall end March 31, 2010. Each agreement shall have two options to renew for a period of one year each.

EARLY TERMINATION RIGHT: The Board shall have the right to terminate each agreement with 30 days written notice.

USE OF POOL: Schools, regions and central office units are authorized to receive services from the Prequalified Consultants through an informal proposal process by way of statement(s) of work. Prior to use of any Consultant, User must send the proposed statement(s) of work to Risk Management for specific insurance language.

User shall send proposed statement(s) of work to all Consultants pre-qualified for the services requested. Central Office staff will provide technical assistance in securing these services and a notice to proceed letter will be issued by the Chief Purchasing Officer. This notice to proceed shall include a detailed scope of services and the dollar amount awarded for such services. Payment shall be made by Purchase Orders.

SERVICES: Each qualified firm shall provide those types of services identified in their agreement. User will send proposed statement(s) of work to all Consultants pre-qualified in the category of services being requested. The various categories of Professional and Audit Services are:
