## APPROVE ENTERING INTO AN AGREEMENT WITH CLASSROOM, INC. FOR THE PURCHASE OF COMPREHENSIVE CURRICULA AND PROFESSIONAL DEVELOPMENT SERVICES FOR USE IN THE OFFICE OF EXTENDED LEARNING OPPORTUNITIES KEEP KIDS LEARNING SUMMER PROGRAM

## THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into an agreement with Classroom Inc. for the purchase of comprehensive curricula and professional development services for use in the Office of Extended Learning Opportunities' Keep Kids Learning Program at a cost not to exceed \$296,945.60. This Vendor is a sole source provider of the summer curriculum. A written agreement for this purchase is currently being negotiated. No goods or services may be ordered or received and no payment shall be made to Vendor prior to the execution of the written agreement. The authority granted herein shall automatically rescind in the event a written agreement is not executed within 90 days of the date of this Board Report. **TERM:** The term of this agreement shall commence the date the agreement is signed and shall end September 30, 2008.

**EARLY TERMINATION RIGHT:** The Board shall have the right to terminate this agreement with 30 days written notice.

**DESCRIPTION OF SERVICES AND PURCHASE:** Classroom, Inc. will provide Extended Learning Programs which will allow students to develop and practice core literacy as well as business, collaboration, problem solving and organization skills as they assumer the role of the decision maker in various industries. The program includes simulation software programs, print materials, assessments, professional development and trainings as described below.

**OUTCOMES:** This purchase will result in the successful implementation of the Keep Kids Learning Summer Program offered through the Office of Extended Learning Opportunities. The program will be offered at twenty five elementary schools and two high schools during the summer of 2008, serving approximately 3,000 students. The Classroom Inc. curricula will provide comprehensive math, literacy, and science programs that will enhance student academic enrichment during the summer months. Academics will be taught by Chicago Public School teachers during the morning session for approximately four hours each day, four days per week for six weeks.

**COMPENSATION:** Vendor shall be paid in accordance with the unit prices contained in the agreement which will total \$296,945.60, with total compensation under the agreement not to exceed that amount.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the written agreement. Authorize the President and Secretary to execute the agreement.

**AFFIRMATIVE ACTION:** Pursuant to Section 5.2 of the Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services contracts, M/WBE provisions do not apply to those firms who operate as Not-for-Profit organizations.

LSC REVIEW: Local School Council approval is not applicable to this report.

## **GENERAL CONDITIONS:**

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
