RESCIND BOARD REPORT 98-0622-RS26

RESOLUTION DESIGNATING FOR ACQUISITION 2524 THROUGH 2546 SOUTH BLUE ISLAND AVENUE AND 2219 THROUGH 2267 WEST COULTER STREET FOR NEW SCHOOL AND EDUCATIONAL FACILITIES TO RELIEVE OVERCROWDING IN THE PILSEN COMMUNITY

WHEREAS, the Board of Education of the City of Chicago (the "Board") is a body corporate and politic organized and existing under and by virtue of the provisions of the School Code, 105 ILCS 5/34-1 *et seq.*, as amended (the "Code"); and

WHEREAS, the Board exercises general supervision and jurisdiction over the establishment and maintenance of public schools and other educational facilities of the Board including playgrounds and other recreational facilities; and

WHEREAS, Section 5/34-20 of the Code authorizes the acquisitions of title to real estate, by purchase, condemnation or otherwise, for school purposes, such title to be held for the use and benefit of the Board in the name of the City of Chicago in Trust for the Use of Schools; and

WHEREAS, on June 22, 1998 the Board adopted Resolution No. 98-0622-RS26 designating the property described in Exhibit A for the acquisition for new school and educational facilities to relieve overcrowding in the Pilsen community;

WHEREAS, the Board has determined that at this time the acquisition of the property described in Exhibit A is not required for school and other educational and recreational purposes.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Trustees of the Board of Education of the City of Chicago as follows:

- 1. The property described in Exhibit A is not required for school and other educational and recreational purposes at this time.
- 2. The Board hereby rescinds Resolution 98-0622-RS26 designating for acquisition the property described in Exhibit A for school and other educational and recreational purposes.
- 3. This resolution is effective immediately upon its adoption.
