WHEREAS, Section 5/34-20 of the Code authorizes the acquisitions of title to real estate, by purchase, condemnation or otherwise, for school purposes, such title to be held for the use and benefit of the Board in the name of the City of Chicago in Trust for the Use of Schools; and

WHEREAS, on June 28, 2006 the Board adopted Resolution No. 00-0524-RS16 designating the property described in Exhibit A for the acquisition of property for the Benjamin E. Mays Community Academy;

WHEREAS, the Board has determined that at this time the acquisition of the property described in Exhibit A is not required for school and other educational and recreational purposes.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Trustees of the Board of Education of the City of Chicago as follows:

- 1. The property described in Exhibit A is not required for school and other educational and recreational purposes at this time.
- The Board hereby rescinds Resolution 00-0524-RS16 designating for acquisition the property described in Exhibit A for school and other educational and recreational purposes.
- 3. This resolution is effective immediately upon its adoption.
