ADJUST THE ATTENDANCE AREAS OF REED, NICHOLSON, BANNEKER AND PARKER ELEMENTARY SCHOOLS AND CHANGE THE GRADE OFFERINGS OF REED ELEMENTARY SCHOOL

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That effective July 1, 2009, the attendance areas of Walter Reed Elementary School (unit 6870, school ID 610264) ("Reed"), located at 6350 South Stewart Avenue, Nicholson Elementary School (unit 2200, school ID 609793) ("Nicholson"), located at 6006 South Peoria Street, Benjamin Banneker Elementary School (unit 6880, school ID 610265) ("Banneker"), located at 6656 South Normal Boulevard, and Francis W. Parker Community Academy (unit 5270, school ID 610112) ("Parker"), located at 6800 South Stewart Avenue, be adjusted and changed and that the grade offerings of Reed be changed as described below.

DESCRIPTION:

Currently, Reed serves kindergarten through eighth grade in addition to offering pre-kindergarten programs. Effective July 1, 2009, Reed will decrease its grade structure to serve grades first through eighth and, thereafter, Reed will decrease its grade offering by one grade per year (second through eighth). Students not yet enrolled in kindergarten who reside within the current Reed attendance area will be assigned to Nicholson, Banneker or Parker as of the 2009-2010 school year.

Pursuant to the Board of Education's Policy on the Review and Establishment of School Attendance Boundaries, 05-0622-PO1, a public hearing was convened on February 4, 2009, following the issuance of proper notice to receive public comment on the CEO's proposal to adjust the attendance area boundaries of Reed, Nicholson, Banneker, and Parker and to adjust the grade offerings of Reed due to reasons associated with space utilization. An independent hearing officer received comments and supporting documents at the hearing and kept the record open after the meeting to receive additional written comments or documentation. Transcripts of the public hearing have been provided to the Board. The hearing officer has prepared and submitted a report regarding the CEO's proposal in which the hearing officer recommends the adjustment of the attendance area boundaries of Reed, Nicholson, Banneker, and Parker elementary schools and the adjustment of the grade offerings of Reed. After receiving the hearing officer's report, the CEO has determined to recommend that the Board approve the attendance area and grade offerings adjustments noted below effective July 1, 2009 and reassign Reed's attendance area to the Nicholson, Banneker, and Parker one grade per year from the 2009-2010 to the 2016-2017 school years.
