RESOLUTION APPROVING THE ELECTION AND APPOINTMENT OF FIFTEEN MEMBERS TO THE LOCAL SCHOOL COUNCIL ADVISORY BOARD

WHEREAS, Public Act 89-15 empowered and directed the Chicago Board of Education to establish a Local School Council Advisory Board ("LSCAB") comprised of active Local School Council members to serve in an advisory role to the Chicago Board of Education; and

WHEREAS, the LSCAB will serve: in an advisory capacity to the Chicago Board of Education on issues related to Local School Councils, including elections, operations, powers and duties, and other issues regarding the school district, as requested by the Board; and as liaison between Local School Council members and senior staff; and

WHEREAS, a fifteen-member LSCAB was established in 1996 to serve a two-year term; and

WHEREAS, the fifteen members of the LSCAB are comprised of six members, one from each cluster, elected by currently active Local School Council members and nine members appointed by the Chicago Board of Education, with consideration given to racial, ethnic, gender, regional, special interest and category balance;

NOW, THEREFORE, BE IT RESOLVED, that the Chicago Board of Education hereby appoints the following members to the Local School Council Advisory Board for the two-year term beginning July 1, 2009 and ending June 30, 2011.
