RESOLUTION TO REQUEST THE PUBLIC BUILDING COMMISSION OF CHICAGO TO TRANSFER TITLE OF REAL ESTATE FOR VARIOUS SCHOOL SITES TO THE CITY OF CHICAGO IN TRUST FOR THE USE OF SCHOOLS

WHEREAS, the Board of Education of the City of Chicago (the "Board") is a body corporate and politic and organized and existing under and by virtue of the provisions of the School Code, 105 ILCS 5/34-1 et. seg. as amended; and

WHEREAS, the Board exercises general supervision and jurisdiction over the establishment and maintenance of public schools and other educational facilities of the Board including playgrounds and other recreational facilities; and

WHEREAS, on July 12, 1956, the Board joined in the organization of the Public Building Commission of Chicago ("PBC"); and

WHEREAS, the PBC holds title to Roberto Clemente Park, Orr Park, Marie Curie Park, and Whitney Young High School (together, the "Property"); and

WHEREAS, the Property was transferred to the PBC for bond financing purposes for the improvement of Board property and the bonds have since been fully repaid; and

WHEREAS, the deed conveying title to the PBC contained a reverter clause stating that title to the Property shall revert to City of Chicago in Trust for Use of Schools upon retirement of the bonds; and

WHEREAS, there is no longer any purpose for the PBC to hold title to the property, state statute requires the Board's property to be held in trust by the local municipality, and transferring title back to the City of Chicago in Trust for the Use of Schools is required to be in compliance with the spirit and letter of the law.

WHEREAS, the City of Chicago has agreed to accept title in trust for the use of schools on behalf of the Board.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CHICAGO BOARD OF EDUCATION:

- 1. The Recitals as stated above are referenced and incorporated herein.
- 2. The PBC, on behalf of the Board, is authorized to convey title to the Property, as legally described in Exhibit A, to the City of Chicago in Trust for the Use of Schools.
- 3. The Board of Education requests and authorizes the PBC to transfer title to the Property legally described on Exhibit A to the City of Chicago in Trust for the Use of Schools by executing a Quit Claim Deed of Reconveyance.
- 4. The Executive Director or Secretary, or designee of the PBC are authorized to execute on behalf of the Board, a Quit Claim Deed of Reconveyance as well as other ancillary documentation required to dedicate transfer title to the City of Chicago In Trust for Use of Schools.
- 5. This Resolution is effective immediately upon its adoption.
