


# Whole School Safety Update

## Status Since August 2021 Board Meeting:

- We have resolved the open IGA issue:
  - Staffing at schools will meet the commitments made to LSCs on honoring their votes
- Over \$3.2M has been reinvested in restorative justice/climate and culture/other interventions
- Schools may continue to re-evaluate their decisions around the SRO program if they wish to remove SROs
  - Additional schools are beginning to contemplate SRO re-evaluation as they have entered the school year
  - One school LSC, King HS, has since voted to remove their second SRO
- CPD has been providing special attention as we transition back to school
  - We appreciate CPD's commitment to keeping all school communities safe
